The course Cohabit. Design and Architecture in the context of International Cooperation is conceived as a postgraduate programme organised by ELISAVA Escola Superior de Disseny (Barcelona, Spain), funded by the Agència Catalana de Cooperació al Desenvolupament (Generalitat de Catalunya, Spain), in collaboration with the Instituto Técnico Superior José Antonio Echeverría (Havana, Cuba) and sponsored by the Sociedad Civil Patrimonio, Comunidad y Medio Ambiente (Havana, Cuba).

The course is aimed at university graduates who have recently been awarded a degree. The course is to enable them to acquire specific training that broadens the basic education of an ordinary course of studies.

2. Introduction

In many places throughout the world there are urgent housing problems as a consequence of the large-scale movement of individuals and families, the arrival of immigrants in the cities of the first world, the reconstruction of cities completely destroyed by war or because of emergency conditions caused by natural disaster.

If the construction of emergency shelters following a disaster is analysed, it can be determined that there are very few issues in the construction field in which so much effort and money has been expended and yet in which, paradoxically, so little is known. We do not know anything about the function of local communities in rescue and reconstruction operations. We know very little about the usefulness and effects of our aid in the long term, whether tents or other types of shelter are concerned.

It is not easy to find an answer to the disillusionment that many people experience in relation to housing (elderly people, foreigners, young couples, university students), a disillusionment that is combined with a difficult situation in the housing market. In the same way, it is not easy for state intervention, the construction business, the property market and academic research to reach agreement.

Projects of "emergency housing centres" meant to meet temporary housing needs in many cases seem to be the only viable and possible solutions. These are centres of initial reception for immigrants, homes for the elderly, and single furnished rooms for workers and students.

These solutions only contribute to the disintegration of the social fabric of any city, relegating collective or private rituals such as the gathering, the encounter or the need for solitude.

The urgency of finding an answer to the housing shortage is a consequence of the present conditions in the construction business where state intervention has abandoned almost the entire sector to a property market not interested in meeting this need. At the same time, the current state of academic research in the field of Architecture has failed to provide any sort

of critical analysis concerning the real needs and values of human beings (a certain culture, an education, religious and domestic rituals), concentrating attention exclusively on aesthetic problems.

The current environment requires more involvement from universities and political institutions. It is the task of universities to define research avenues capable of designing viable solutions from a socioeconomic, cultural and technical perspective.

This approach will lead to the only possible research avenue: that which fosters relations between forms and the real needs of users. In this way, reference to comparative architecture (oriented not only towards theoretical research but also to knowledge of practices in other cultures), the appropriate technologies and research action (that privileges research born out of and structured for rapid application to real situations) will not be overlooked.

If the habitat of thousands of people is worth more than any attempt at planning, reflecting on the health conditions in cities that suffer housing problems means thinking not only about "typologies of accommodation", but also about possible "intervention strategies". The answer for those cities that continue to present themselves as hypermarkets of consumerism - where there is only room for processes that neutralise differences -, the issue of new types of accommodation aimed at users other than the traditional family will not only mean intervention by the welfare state but, above all, an experience with new forms and new routines in the contemporary habitat. This is not about utopian or visionary projects. Only simple, concrete and indispensable proposals for meeting the visible needs of all of us.

- Create a discussion forum for sharing the experiences of professionals who operate and are interested in projects in "difficult" parts of the world (humanitarian programmes, international organizations, research centres, freelance professionals).
- Guide participants towards specific professional training that broadens the basic education of an ordinary course of studies and facilitates the development of in-depth knowledge of the methods and working practices relevant to carrying out interventions in the urban sector of developing countries or the fourth world.
- Improve the quality of response in the area of housing and emergency situations.
- Look for solutions for a habitable space fit for those managing to survive abandoned on the outskirts of major cities in the first world.
- Improve knowledge of the methods and working practices for intervening in areas in which there are racial, social, economic and political conflicts; areas which are no longer exclusively found in developing countries.
- Teach the ability to recognise and identify opportunities and problems, using the tools appropriate to national and transnational development.
- Administering cooperation procedures, applying appropriate technological solutions, taking account of the specific conditions of the country which is the object of intervention.
- Improve knowledge of architecture as a discipline linked to social research.
- Make it possible for spaces to express the identities contained within them. Guarantee by means of an open project the right of every inhabitant to free himself from spatial homogenisation.

A. Course structure

The structure of the course Cohabit. Design and Architecture in the context of International Cooperation is built around a series of lectures, seminars and workshops organised into the following modules:

Theoretical module

This is divided into lectures, given by specialists as specific reflections within the activities of the programme, and seminars based on the extended participation of a specialist on a specific subject of study.

Practical module

This is divided into 3 workshops and professional practicals.

Each workshop will be led by an expert in the subject under study. The workshops will be used to look for answers and solutions to issues arising from projects proposed in the theoretical discussions (lectures and seminars). The professional practicals will take place in conjunction with the *Oficina del Historiador de la Ciudad de La Habana and the Taller Integral del Barrio de Cayo Hueso.*

Tutorials

The purpose of these is to assist students in progressing effectively with their research dissertations. Each dissertation will be related to one of the research areas listed in the postgraduate programme.

The taught component of the course consists of 180 hours (18 credits) organized as 20 hours (2.0 credits) of research supervised by a tutor and 160 hours (16 credits) divided into the following lectures, thematic seminars, workshops and professional practicals:

ELISAVA Escola Superior de Disseny has set aside 20 of the **35 available places** of the postgraduate course for a programme of grants that will be allocated as follows:

• 10 grants for professionals from Cuba's regions.

The selection of the Cuban candidates will be the responsibility of the Instituto Técnico Superior José Antonio Echeverría (Havana, Cuba) and the Sociedad Civil Patrimonio, Comunidad y Medio Ambiente (Havana, Cuba).

• 10 grants for professionals from Spain and Latin America.

The selection of the Spanish candidates will be the responsibility of ELISAVA Escola Superior de Disseny (Barcelona, Spain) and the selection of the Latin American candidates will be the responsibility of the Latin American universities invited to participate in the programme.

The course will have **open registration for a total of 15 professionals** who operate locally in decision-making or who implement policies that respond to processes of local development in complex and difficult areas in the social, urban and architectural context of their respective countries, or who may have developed a completed professional project related to one of the study and project subject areas proposed in the postgraduate course.



THE REGISTRATION FEE FOR THE COURSE WILL BE 3000 EUROS

THE FEE INCLUDES:

- Student visa valid for three months from the start of the course
- Cuban exit tax

THE FEE DOES NOT INCLUDE:

- Medical insurance
- Books and study materials
- Individual expenses
- Return airline ticket to Havana (approximately 850 euros from Europe, 600 euros from Latin America)
- Accommodation: in a family home with full pension (approximately 700 euros a month)
